**Application deadline:** July 20, 2020. (Keep in mind that as a vendor, you must either be a teacher or registered for the event. Sometimes registration closes early due to being at capacity so sometimes our vending is full before July 20th)

**Payment deadline:** August 31, 2020.

### Vendor Information

We are expecting to have about 300 faire attendees. **The Marketplace is located outside.** The fee for one **10 X 10 vendor space** (for the weekend) is **\$50.00**. Vendors are responsible for bringing all materials they may need to vend; this includes a TEND, TABLE(s), CHAIR(S), SIDES/TARPS and WEIGHTS (for the tent). Please keep in mind that weather is unpredictable in September in Michigan. We are hoping for sunny skies and beautiful weather, but please come prepared for wind and rain, just in case. Vendor set up will be allowed from 8am – 12 pm on Friday, September 6<sup>th</sup> before the Great Lakes Herb Faire opens. The Marketplace will be open before and after classes and during meal breaks during the Great Lakes Herb Faire. Vendor tear down can begin after Closing Ceremony.

*Great Lakes Herb Faire*, operator of the *Vendor Marketplace* (including Vendor Coordinators and Managers that operate in the future by *Great Lakes Herb Faire*, its affiliates or successors): and its officers, independent contractors, employees, agents board members and volunteers and *greatlakesherbfaire.org*.

1. "Seller" shall mean any vendor, farmer, team member, participant, volunteer, or entity at the *Great Lakes Herb Faire*; seller's employees, agents or volunteers, including family members; and its heirs and assigns.
